1. Call to Order – 5:31 pm by Wickham

2. Welcome & Introductions

Wickham led introductions in the room and online.

3. Public Comment – NONE

4. Review & Consider Approval of Prior LCBC Meeting Minutes – May 28, 2026

Welker/Nelson motioned to approve the May 28, 2026, LCBC minutes as presented; motion carried.

5. Monthly Updates from LCBC Leadership & Partners

a. Commission Chair

Wickham has continued to observe a lot of activity as Charter enters the final months of installing its RDOF fiber services. Resident inquiries about the project have largely ceased by this point.

b. Public Service Commission (PSC)

i. BEAD Program Updates

Leonard reported that 20 of the 28 BEAD grant awardees have executed agreements for all their projects, including Frontier, Brightspeed, and SpaceX in Lincoln County. Bertram requested an extension and now has until July 3rd to execute their contract. A number of BEAD awarded project adjustments were announced last week but they did not impact Lincoln County. The PSC's BEAD web page can be referenced for additional updates and data information.

Leonard also shared information about the PSC's *State Broadband Expansion Grant*, which is due July 27 and can be used to bring service to currently unserved locations, including sites that already have other funding pledged via programs like BEAD. However, applicants must explain why these sites need additional state funding if they are already scheduled to receive service through BEAD or other funding sources. Lincoln County has 6,149 potentially eligible locations, including 189 locations that are not part of any other in-progress projects. Most applicants are expected to be ISPs but public-private partnerships are encouraged; UW-Extension will be hosting a webinar on June 29 with more information about this process. c. *Internet Service Providers (ISPs)*

i. *Charter RDOF Project Implementation*

Guild has received most of the Q3 updates for the RDOF implementation schedule and will be uploading a new map as soon as the final details are verified. She noted that a lot of areas are almost fully complete pending final easements or limited make-ready work. She also encouraged anyone monitoring specific areas to check the updated map because some of the timelines have been adjusted by up to three months, although most are still on track to be completed by fall. She also informed attendees that Charter is preparing to hold an event celebrating the completion of the RDOF project in Lincoln County and that LCBC members and local government officials will be receiving emailed invitations later this year.

ii. *Other ISPs*

Guild made contact with Lincoln County's new Verizon/Frontier representatives this week and they have been added to the LCBC email communications list.

d. *Action Team Members*

Multiple attendees commented on the extensive fiber installation activity occurring throughout the county due to Charter's RDOF project. Welker also noted that he is aware of several people who recently switched to Starlink satellite internet service due to the very affordable deals currently being offered.

6. Digital Pathways Program

a. *United Way Presentation: Techquity Program and Digital Navigation Services*

Wickham welcomed Debbie Moellendorf, Executive Director for the Merrill Area United Way, and Emily Conklin, Program Director - Connected Communities for United Way of Wisconsin. Conklin shared a PowerPoint presentation that explained the history and impact of United Way's Techquity device lending and digital navigation program. The program began in Milwaukee in 2020 and has evolved over the last six years to become a statewide initiative. The program currently focuses on distributing laptop devices to low-income individuals who do not already have a device in the home. It also offers personalized digital assistance services to qualifying clients. The device lending program's grant ends this year but the United Way is exploring options to continue Techquity's services into 2027 and beyond.

Moellendorf confirmed that 75 people have been enrolled in the program through Merrill Area United Way and described the enrollment and participation processes. She noted that United Way's funding partners strongly support the program. Community service partners are the primary source of referrals and support.

Conklin and Moellendorf answered questions related to how the Digital Navigator program works, how it is supported, and the types of assistance that are provided. Conklin shared information about the United Way's [CommunityUpskill.org](https://www.communityupskill.org) website, which provides free online digital skills training for the general public. Attendees discussed ideas for how to support and/or compliment the Techquity program locally, such as adding links for digital resources to the Broadband web page, finding additional donors for the laptop device program, and/or assisting Moellendorf with updating her list of free wi-fi locations. The LCBC will continue discussing ideas at the next monthly meeting.

7. Annual Review of LCBC Organizational Guidelines

Attendees completed the annual review of the LCBC Organizational Guidelines. They felt that the mission and goals may need to be updated to better reflect the anticipated shift from service installation to service utilization and agreed by consensus to bring this topic back to the next meeting. They briefly discussed reducing the LCBC meeting schedule frequency but decided to keep scheduling meetings monthly so that they were prepared to be responsive to time-sensitive items and to cancel meetings as appropriate. No other changes were recommended.

Wickham briefly revisited the PSC Broadband Expansion Grant topic. He offered to contact Charter/Spectrum to determine whether they plan to pursue this funding opportunity as a means to complement their RDOF project. Attendees agreed by consensus that he should reach out and, if appropriate, also offer non-monetary support consistent with the support offered to ISPs during the original BEAD process.

8. Future LCBC Meetings Information

a. Future Agenda Topic Suggestions

The next LCBC meeting will focus on reviewing the information gathered during the Digital Pathways outreach activities that took place throughout the first half of 2026 and then use that feedback to create or update the LCBC's primary goals, action items, mission and/or vision statements.

b. Confirmation of Next Commission Meeting Date/Time/Location

Attendees agreed by consensus to cancel the July 2026 LCBC meeting due to some potential scheduling conflicts and a lack of time-sensitive topics. The next LCBC meeting will be held on **Thursday, August 27**, at 5:30 pm in the Lincoln County Service Center; online access will be provided.

Organizational Guidelines

Last Updated: 05/28/2026

The Lincoln County Broadband Commission (LCBC) is a non-governmental entity designated to oversee activities related to broadband/internet service expansion efforts throughout Lincoln County, Wisconsin.

MISSION: To coordinate activities and collaborations that will efficiently and cost-effectively provide accessible, affordable, high-quality internet service options throughout Lincoln County.

VISION: Every Lincoln County resident, business, and visitor can reliably access affordable quality internet service options that meet their unique needs.

GOALS:

- Achieve cost-effective quality internet service availability in all areas of Lincoln County with an emphasis on broadband service featuring speeds no less than 100 Mbps download/20 Mbps upload.
- Locate & implement viable resources, including funding opportunities, that will help with the strategic implementation and utilization of accessible quality internet options.
- Identify, develop, and/or promote educational tools to help Lincoln County residents and businesses increase their personal digital literacy and improve overall internet service utilization.

HISTORY: The LCBC was formed in mid-2023 to replace the Lincoln County Broadband Ad Hoc Committee. It was based on recommendations from the Lincoln County Board of Supervisors as presented in Resolution 2023-07-47. The current LCBC was formed as a commission/subcommittee under the Lincoln County Economic Development Corporation (LCEDC) by a majority vote at the August 2023 LCEDC Board meeting.

MANAGEMENT: The LCBC is housed under the Lincoln County Economic Development Corporation (LCEDC) and is considered a non-governmental commission. LCBC meeting agendas/minutes are publicly available on the LCEDC website. Other LCBC documents are retained by the LCEDC Executive Director on behalf of the organization. Organizational Guidelines are publicly reviewed and updated by the Commission annually at the June meeting.

MEETINGS: Regular monthly meetings are held on the 4th Thursday of each month at 5:30 pm at the Lincoln County Service Center in Merrill unless otherwise specified by the Chair or their designee. An option for virtual (online) meeting attendance will be provided and shared as part of the meeting agenda whenever reasonably possible. Meetings will be public and open to all interested parties. All attendees may participate in meeting discussions with Chair approval.

LEADERSHIP: The LCBC Action Team has primary responsibility for overseeing activities related to executing the LCBC's mission. Only approved members of the Action Team may vote on LCBC agenda action items. The Action Team consists of nine (9) members approved by a majority vote who serve 3-year staggered terms ending at the May meeting. At least five members (or their designated proxy) must be present for a quorum. An Executive Team consisting of a Chair, Vice Chair, and Secretary must be elected out of Action Team members for 1-year terms that take effect at the May meeting. Action and/or Executive Team vacancies should be filled by a majority vote at the next scheduled LCBC meeting.
